






Do Hereby:

1. Acknowledge that it is imperative that the school has our latest details on record in the event of an emergency. The information provided is to the best of my knowledge true and correct.
2. Confirm that I have read and understood the school rules, procedures, and policies as per the information brochure.
3. Understand that the school closes at 13:00 for half day and 17:30 for full day. I understand that there will be a late collection fee added to my account if I do not collect my child timeously.
4. I am aware of the following payment obligations: A non-refundable registration fee, quarterly and equipment fees payable at the beginning of each term, four times a year (January, April, July and October). A monthly fee is payable every month at the beginning of each month (Monthly fees are payable for 12 months from January – December of every year). All fees must be settled by the first of every month. (If not settled, penalties will be added to my account for late payments.) If your child is not at school, the fees are still payable.
5. I agree that I do understand the following regarding giving notice to the school:
Written notice must be given as soon as I know that my child will be leaving the school. One calendar month is required. October, November, and December (last term) will not serve as notice period months. The assumption is that all Gr R's will leave at the end of the year unless a re-submission pertaining to the child's development is required.

Millennium Kids Montessori hereby reserves the right to give any parent a notice to remove their child from the school in the following instances: If there is a discipline problem that does not improve after discussions and consultations. If it is felt that the parents are being disruptive to any of the processes of the school's operation or habitual late payers will be asked to remove their children from the school.


6. I understand that if my fees are not paid by December, that my child will not automatically have a space in the school for the following year, and if I do have a space that I have to re-register again.
